OVER THE LAST 25 YEARS, THE CENTER HAS STARTED A MULTITUDE OF PROGRAMS, ENGAGING HUNDREDS OF VOLUNTEERS IN THOUSANDS OF HOURS OF SERVING OPPORTUNITIES, AND HELPING COUNTLESS RESIDENTS SECURE THE RESOURCES THEY NEED TO SURVIVE. FOOD PANTRIES: CCPC OPERATES THE LARGEST FOOD PANTRIES IN SUMMIT AND WASATCH COUNTIES.
